NOTIFICATION

The hearing of cases by the various Benches of the Tribunal is taking place through Video Conferencing mode in view of the Covid-19 pandemic situation and in view of new Virus Strain which is increasing day by day. Notifications in this behalf were issued from time to time and the last of such notification was on 14.12.2020.

The feasibility of resuming the physical hearing is seriously considered. It is, however, found that it is not possible to resume same at this stage. The factors that contributed for this are-

- (a) Limited space and infrastructure at the Benches of the Tribunal;
- (b) Inadequate staff at various levels;
- (c) Substantial number of the staff having been affected by the pandemic, and
- (d) Reluctance on the part of the Advocates to physically attend the hearing.

Notwithstanding the difficulties, the cases are being taken up through Video Conferencing every day almost on par with the regular functioning of the Courts. Seriousness of the pandemic is yet to record the expected level of decrease.

Hence, it is decided to continue the present arrangement till 31.01.2021. However, if it becomes possible for the Benches at any places to conduct physical hearing, a decision in that behalf shall be taken by the concerned HODs.

If any significant change takes place in the meanwhile, revised orders would be issued.

This issues with the approval of the Hon'ble Chairman.
