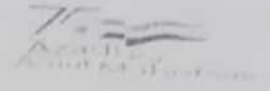

**ORDER**

Whereas Shri Sailesh Kumar Pandey filed online RTI applications dated 23.10.2021, bearing registration No.CADMT/R/E/21/00708, wherein the applicant requested for providing copy of note sheet of screening/ selection committee dated 15.02.2008 (NTRO), attached as an annexure in OA 35/2013, TS Negi Vs. UOI filed in CAT, PB, New Delhi.

And whereas, the CPIO vide his reply dated 28.10.2021 stated that in the judgement passed by the Hon'ble Supreme Court in Civil Appeal No.1966-1967/2020 (Chief Information Commissioner Vs. High Court of Gujarat and Another), it has been held that in the absence of inherent inconsistency between the provisions of RTI Act and other law, overriding effect of RTI Act would not apply and the information to be accessed/certified copy on the judicial side to be obtained through the mechanism provided under the Rules, the provision of the RTI Act shall not be resorted to. The CPIO has further stated that since there is a provision under the CAT rules of practice 1993 for grant of certified copies and free copies, therefore the applicant may apply for obtaining the copies of orders/documents etc. by way of proper application as provided under Chapter XVIII of CAT Rules of Practice, 1993.

And whereas, the appellant, being aggrieved by the decision of the CPIO, has now filed an appeal dated 05.11.2021 bearing Registration No.CADMT/A/E/21/00056.

And whereas, the undersigned has examined all relevant documents and it has been observed that the reply furnished by the CPIO is as per the provisions of the RTI Act, 2005 and in accordance with the judgment of Hon'ble Supreme Court of India on the matter.

Now, therefore, in view of the above, the under-signed disposes off the appeal without any further instructions to the CPIO.
