**NOTIFICATION**

Vide Notification dated 15.08.2020, the physical hearing of the cases in the Benches of the Tribunal was kept on hold till 31.08.2020. The Notification issued by the Ministry of Home Affairs relaxing the restriction is perused. The existing situation, as regards spread of COVID pandemic is also taken into consideration.

It is found that the situation is not ripe as yet for resumption of physical hearing. It is also learnt that the response from the Advocates for physical hearing in the Courts is not that much encouraging.

It is, therefore, decided that the existing state of affairs shall continue till 30.09.2020 or until further orders, whichever is earlier.

In view of the above, the regular hearing in the Benches of the Tribunal shall remain suspended till 30.09.2020. However, the existing arrangement of hearing the cases through Video Conferencing shall continue.

Fresh dates of hearing of the cases which are scheduled to be taken up between 01.09.2020 to 30.09.2020 shall be re-notified by the Registry.
