EARLIER POSITION HELD	<p>Enrolled as Advocate in 1981 with Bar Council of Karnataka and started practice in Dharwad. After practicing few years in Dharwad, moved to Bangalore and joined the Chambers of Prof. Ravi Varma Kumar, a known Constitutional expert, veteran lawyer and former Advocate-General of Karnataka. Working with Prof. Ravi Varma Kumar, practiced in Civil, Criminal and Constitutional matters before the Bangalore City Civil Courts and the Hon'ble High Court of Karnataka. In 1984, one of the cases conducted is reported in the Karnataka Law Journal, Official Law Journal of Karnataka High Court. In the meantime, worked as honorary lecturer in a Law college in Bangalore for a year.</p> <p>In 1987, selected in Karnataka Judicial Services and appointed as Judicial Magistrate First Class, Anekal Taluka of Bangalore Rural District, Karnataka. Demitted the post of Judicial Magistrate First Class in 1989.</p> <p>In 1990 appointed as Government Advocate for Government of India under Ministry of Law and Justice in the Hon'ble Supreme Court of India and later promoted as Senior Government Advocate. During the tenure of 26 years as Govt. Advocate in Hon'ble Supreme Court from year 1990 to 2016, conducted / participated in several cases of various subjects including Excise, Customs, Income Tax, Land Acquisition, Anti-Dumping, Corporate, Arbitration, Criminal (IPC, NDPS, Preventive Detention, Economic Offenses, etc.), Service, Inter-state Dispute, Environmental, Constitutional Validity of Amendment to the Constitution, interpretation of provisions of the Constitution, Parliamentary Enactments. During this period, worked with Attorney Generals, Solicitor Generals and Addl. Solicitor Generals of the Government of India.
