NOTIFICATION

In pursuance of CAT, PB, New Delhi, Notifications dated 02.05.2020 and 17.05.2020, it is hereby notified for general public and members of the Bar that this Bench has decided to entertain the fresh Original Application(s) of extremely urgent nature through Video Conferencing, for which the following procedure is required to be adopted :-

1. Wherever a litigant or an advocate considers it appropriate that a case involves extreme urgency, he will draw a one page synopsis explaining the nature of the case and the urgency involved therein. He will submit the said synopsis on the e-mail i.e. filing.jpr-cat@gov.in to the Joint Registrar.
2. After receipt of the synopsis, the matter will be taken up with the competent authority and if the competent authority agrees, the advocate or the party concerned will be informed at his given telephone/Mobile Number that his request has been accepted by the competent authority to take up the matter for hearing through video conferencing and he may file an Original Application online. The video conferencing shall be conducted through "Vidyo Mobile" App, which can be downloaded from the site <http://ecourtvc.nic.in>.
3. The online Original Application will be received by the Scrutiny Clerk, who will scrutinise the Original Application and in case while scrutinising the Original Application, any defect is found therein, he will notify the defect(s) to the advocate/party concerned telephonically and through email.
4. The moment, the defect (s) pointed out by the scrutiny clerk are removed by the advocate/party concerned and the Original Application is found in order, he will register the Original Application, allocate the registration number and take a print out of the same in the Bench itself. Thereafter, the date and time of hearing through video conferencing will be notified by the Registry of the Bench.

However, before starting the hearing through video conferencing, the advocate/party concerned should arrange the following:-

- (a) In the mentioning application, the Advocate/Party-in-person must specify as to whether he would connect to the Hon'ble Bench through video conferencing by using his/her own Desktop/Laptop/Mobile on the given time and date.
- (b) In this regard, parties may kindly note that Desktop/Laptop provide stable connectivity for a video conferencing, whereas, signal drop/incoming call on Mobile devices can disconnect such devices from an ongoing video conferencing.

(c) The Original Application may be submitted in PDF format alongwith scanned copies of relevant documents (Annexures) and may be sent through e-mail to the respondents and to this tribunal at filing.ipr-cat@gov.in


(d) The Advocate/party concerned is also required to provide an alternate telephone/mobile number to contact in case of any interruption during Video Conferencing
